## SPECIAL PROVISIONS

1. PLANT-MIXED BITUMINOUS MIXTURE

The 2018 Edition of the Minnesota Department of Transportation "Standard Specifications for Construction", shall apply on this contract, except as modified and/or supplemented below:

Bituminous Patching Mixture (Item 2231): provide a mixture consisting of a prepared mix of fine aggregate and bituminous material in accordance with the requirements in TABLE 2231-1.

Wearing Course Mixtures (Item 2360): the bituminous material for the mixture shall be PG58S-28, Performance Grade Asphalt Binder. Mix designation numbers shall be SPWEA240B for SP 9.5 mixture and SPWEB240B for SP 12.5 mixture.

The bituminous mixture bid under this proposal shall include the bituminous material, aggregates, mixing, loading onto county trucks at the plant and all other labor incidental there to.

2. ESTIMATED QUANTITIES

The provisions of 1903 of the specifications do not apply to this contract and the County reserves the right to increase or decrease the quantities in any amount as required for the season without any adjustment in the unit price as bid.

3. TERM OF CONTRACT

The time period covered by this proposal shall be the 2020 construction/maintenance season and will be from the date of this proposal through April 30, 2021.

4. BASIS OF PAYMENT

Payment will be made for materials upon presentation of an invoice to the County Engineer for review and acceptance. Payments shall be processed on a monthly basis.

5. BID SECURITY

Bid security will not be required on this contract.

6. AWARD OF CONTRACT

The County reserves the right to accept or reject any or all bids, or any part of any bid, and to waive any defects or technicalities or to advertise for new bids where the acceptance, rejection, waiving or advertising of such would be in the best interest of the County. The County also reserves the right to award in whole or in part, by item, group of items, or by section where such action serves the County's best interest.

7. SALES TAX

Wright County has exempt status as of January 1, 2014, as per Minnesota Statute 297A.70, Subd.2.

8. INSTRUCTIONS TO BIDDERS
