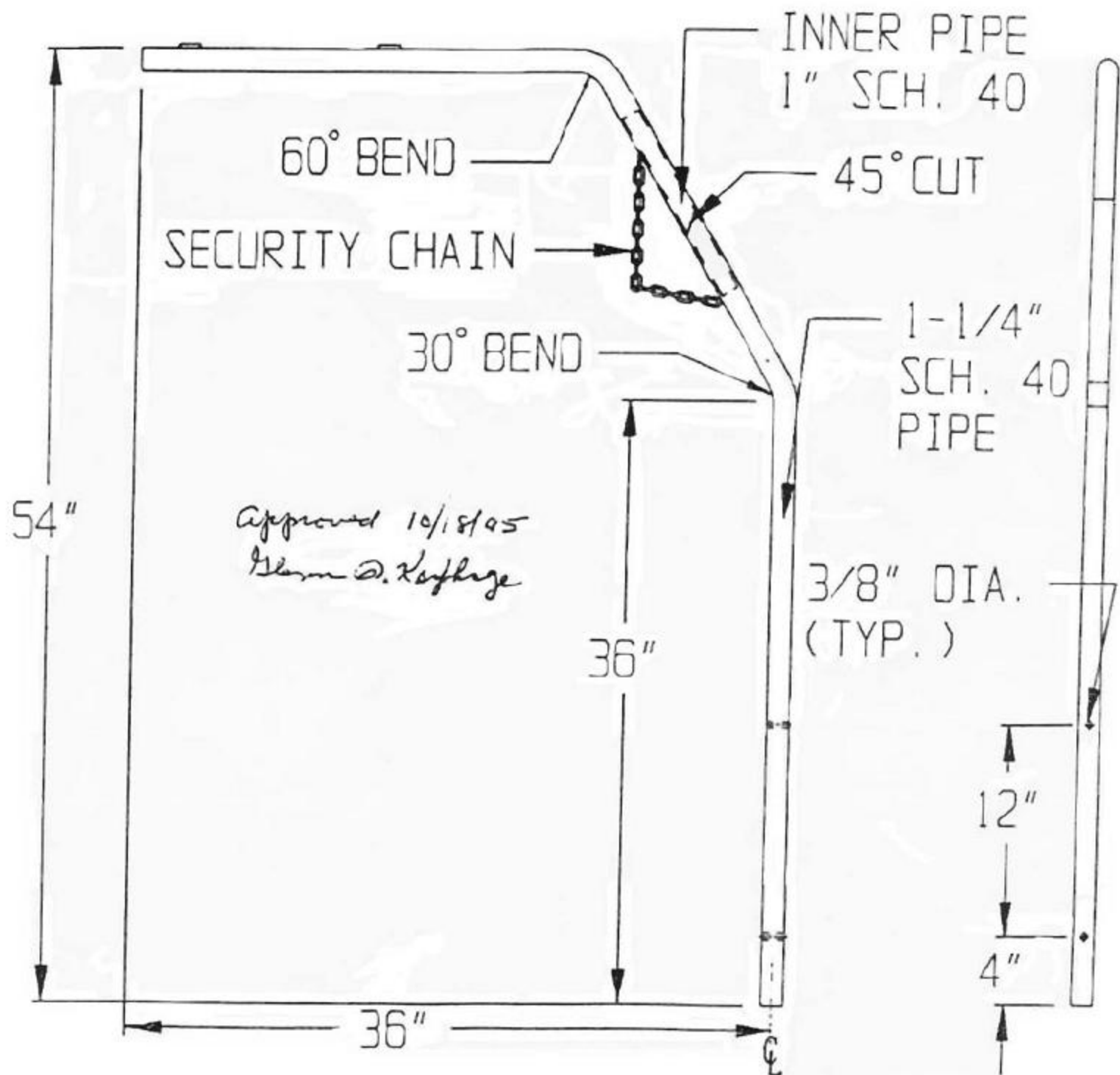
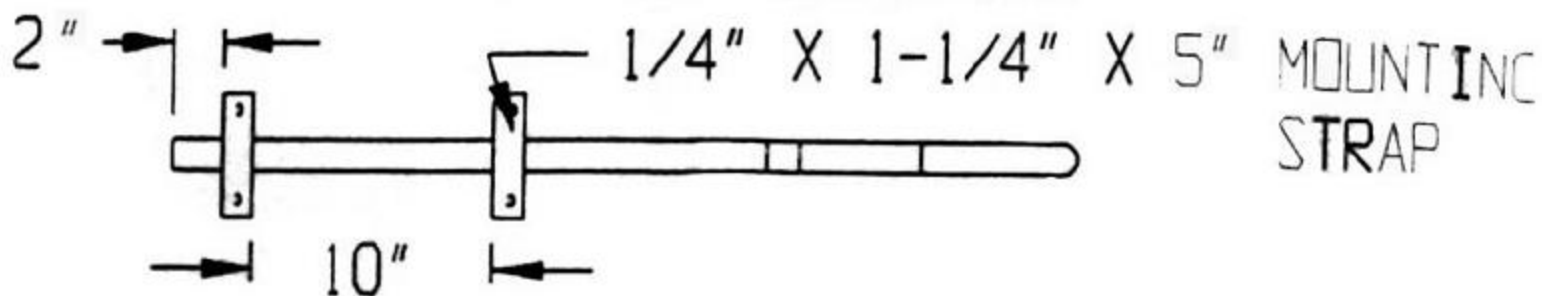

As an applicant, I understand that installation of a mailbox support conforming to county policy is required along all county highways. A copy of the county approved safety support is attached to this form. Wright County Highway Department will install approved mailbox support, upon payment for materials. **INSTALLATION OF MAILBOX SUPPORT WILL OCCUR WITHIN A REASONABLE TIME PERIOD. A MINIMUM OF 2 - 3 WEEKS CAN BE EXPECTED.** Property owner is responsible for purchasing and installing a mailbox conforming with U.S. Postal Service requirements if mailbox is not purchased with the support. Newspaper/advertising delivery boxes, if desired, must be attached to the support alongside the mailbox. Newspaper/advertising delivery boxes shall not be installed on separate posts. I further understand that the mailbox support shall be the property of the property owner upon completion of installation and any further repair or replacement will be at the owner's expense. Also, I shall conform to the requirements as stated in the attached Wright County Mailbox Placement and Maintenance Policy.
