

**Amendment No. 11 to Management Operating Agreement**

**THIS AMENDMENT NO. 11** (the “Amendment”), entered into this first day of June, 2021 by and between the **County of Wright, Minnesota** (“County”), and **Aramark Correctional Services, LLC**, a Delaware limited liability company, having its principal place of business located at the Aramark Tower, 2400 Market Street, Philadelphia PA 19103 (“Aramark”).

**WITNESSETH:**

**WHEREAS**, the County and Best, Inc. entered into an Agreement on November 3, 1999 for the management of the food service operation at the Wright County Jail (as amended, the “Agreement”);

**WHEREAS**, the parties acknowledge the need to address volatility in the cost of food commodities; and

**WHEREAS**, the parties desire to amend the provisions of the Agreement as follows, effective July 1, 2021.

**NOW, THEREFORE**, in consideration of the foregoing and of the mutual promises in the Agreement and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as set forth below. Capitalized terms used but not defined in this Amendment have the meanings ascribed to such terms in the Agreement.

1. **Term:** Both parties agree that the term shall be extended for an additional three (3) years, effective July 1, 2021 through June 30, 2024.
2. **Per Meal Prices:** Both parties agree that the price per meal and the price adjustments to the price per meal during the three (3) year extension are set forth in Attachment A. These prices shall be effective from July 1, 2021 through June 30, 2024.
3. Except as specifically set forth herein, all other terms and provisions of the Agreement shall remain unaffected by this Amendment and continue in full force and effect.
